FINAL AWARD

Upon the Findings of Fact Nos. 1 through 45 and the Interlocutory Order entered herein on June 29, 1960, and the Additional Findings of Fact Nos. 46 through 57 this day entered herein, all of which are hereby made a part hereof, the Commission concludes as a matter of law that the petitioners are entitled to recover from the defendant the following sums, to-wit:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commission that
the petitioners herein, for and on behalf of and for the benefit of the
members and descendants of members of the bands of Ottawa Indians which
entered into the treaties of June 24, 1862 (12 Stat. 1237) and February 23,
1867 (15 Stat. 517), do have and recover of and from the defendant the sum
of \$162,404.07, together with interest on \$30,603.94 at 5 per cent per
annum from March 22, 1869 to March 22, 1934, and 4 per cent per annum
thereafter.
