ORDER RELATING TO ALLOCATION  
OF POINT ELLIOTT TREATY CONSIDERATION

Upon the findings of fact, numbered 1 to 14, inclusive, this day filed herein and made a part of this order, and which are confined to the determination of the proportional share of the consideration provided in the Point Elliott Treaty of January 22, 1855, chargeable against each of the above named claimant tribes, the Commission concludes as a matter of law:

That said above named petitioning tribes are chargeable with consideration received from the United States under the Point Elliott Treaty in the aggregate sum of \$286,231.50, which is allocated to the several petitioners as follows:
