FINAL JUDGMENT

Upon the joint motion of the parties in the above-entitled cases for approval of a stipulation of settlement filed herein on March 11, 1965, which stipulation is hereby incorporated by reference and made a part of this judgment; and upon the further request of the petitioners made at open hearing before the Commission on March 15, 1965, for entry of final judgment in the above-entitled cases, the defendant not objecting thereto, and evidence both oral and written in support of said motions having been received at the hearing held on said motions on March 15, 1965, and considered by the Commission; and supplemental findings of fact and an opinion having this day been made and entered

herein on said matter and which are hereby made a part of this judgment; and it appearing that said stipulation of settlement is fair and just to all of the parties and has been duly approved by the Indian tribes concerned and the authorized representative of the Secretary of the Interior, the Commission concludes as a matter of law that the Yakima Tribe of the Yakima Reservation, petitioner in Docket 161, and the Confederated Tribes of the Colville Reservation, petitioners in Docket Nos. 222 and 224 and intervenor in Docket No. 161, are entitled to recover from the defendant the sum of \$4,088,000.00 less the sums of \$593,000.00, representing payment on the claims, and \$28,000.00 and \$20,300.00, representing allowable gratuitous offsets, leaving a net balance payable of \$3,446,700.00, for the benefit of the Yakima Nation as it was created by the Yakima Treaty of June 9, 1855.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commission that the Yakima Tribe of the Yakima Reservation and the Confederated Tribe of the Colville Reservation do have and recover from the defendant the sum of \$3,446,700.00 for the benefit of the Yakima Nation as it was created by the Yakima Treaty of June 9, 1855.
