ORDER ALLOWING EXPERT WITNESS FEES, STENOGRAPHIC  
 FEES, AND REIMBURSEMENT OF MONIES ADVANCED IN  
 PROSECUTION OF SUBJECT CLAIM BY E. L. CRAWFORD

Upon consideration of the petitions filed herein by the attorneys for the plaintiffs to fix and authorize payment for expert services rendered by Herbert C. Taylor, Jr., Bruce E. Hoffman and William Bushnell Osborne, Jr., for services rendered by Dorothy Crawford, and to allow reimbursement of monies advanced by plaintiffs' attorneys in the prosecution of this claim, the testimony before this Commission on April 14, 1965, and the additional findings of fact in these matters, which are this day filed and made a part hereof,

IT IS THEREFORE ORDERED AND ADJUDGED that E. L. Crawford is hereby awarded and allowed the sum of \$2100.00 to be allocated as payment of the balance due Dr. Herbert C. Taylor, Jr. for services; that E. L. Crawford is hereby awarded and allowed the sum of \$5520.00 to be

allocated as payment of the balance due William Bushnell Osborne, Jr. and Bruce E. Hoffman as reasonable compensation as timber consultants, appraisers and expert witnesses; that E. L. Crawford is hereby awarded and allowed the sum of \$525.00 to be allocated as payment due Dorothy Crawford for services as a secretary, assistant and researcher; and further, that E. L. Crawford is hereby awarded and allowed the sum of \$9782.04 which shall be compensation in full for all sums advanced and expended by him in the prosecution of this claim; and that said sums shall be paid out of the appropriation which Congress has made to satisfy the final award to the plaintiffs herein made by this Commission on August 27, 1962.
