ORDER GRANTING REHEARING


On April 28, 1971, the plaintiff in Docket No. 350-C filed a motion for rehearing of the Commission's determination of the date of taking for valuation purposes, which decision was entered herein on March 30, 1971 (25 Ind. Cl. Comm. 179). On June 11, 1971, the defendant filed a response to the motion.


IT APPEARING to the Commission that in its decision of March 30, 1971, it found that the aboriginal lands of the plaintiff in Docket No. 350-C were acquired by the defendant on April 12, 1870; and it appearing to the Commission, upon examination of the proposed findings of fact and brief of each of the parties, that neither the plaintiff nor the defendant had submitted this issue for decision; and it also appearing that the plaintiff in Docket No. 350-C has not yet offered its evidence pertaining to the date of acquisition of its lands by the defendant; and it being the desire of the Commission that an issue of this magnitude not be decided without all the available evidence; accordingly


IT IS ORDERED that the plaintiff's motion for rehearing be, and the same is hereby, granted.


The parties shall have sixty days from the date of this order in which to submit evidence relating to the date of acquisition of the plaintiffs lands by the defendant. The usual time limits shall then apply to the submission by the parties of proposed findings of fact and brief addressed to the issue of date of acquisition.


