ORDER AMENDING FINDING AND ORDER

On April 19, 1971, plaintiffs in Docket No. 246 filed a motion for rehearing requesting that the Commission amend certain findings and modify its order entered herein on March 30, 1971 (25 Ind. Cl. Comm. 179). On April 30, 1971, plaintiff in Docket No. 113 filed a motion for rehearing requesting that the Commission reconsider its findings, determinations, and portions of its order entered herein on March 30, 1971. On May 7, 1971, plaintiff in Docket Nos. 246 and 350-C filed a response to the Docket No. 246 and Docket No. 113 motions.

For the reasons stated in the opinion accompanying this order, IT IS HEREBY ORDERED that:

1. The second and third calls in finding 26 entered herein on March 30, 1971, are amended to read as follows:

(2) Then northerly in a direct line through Dog Den Butte to the Souris or Mouse River;

(3) Then westerly along the Souris River to a point due west of the southwest tip of Buffalo Lodge Lake (the point where that lake is intersected by South Egg Creek);

2. The second and third calls in paragraph 5 of the order entered herein on March 30, 1971, are amended to read as follows:

(2) Then northerly in a direct line through Dog Den Butte to the Souris or Mouse River;


(3) Then westerly along the Souris River to a point due west of the southwest tip of Buffalo Lodge Lake (the point where that lake is intersected by South Egg Creek);


