Upon the findings of fact, conclusions of law and opinion this day filed herein and which are hereby made a part of this order,

IT IS HEREBY ORDERED that the claims in Dockets 18-K and 341-D be, and the same are hereby, dismissed;

IT IS FURTHER ORDERED that Docket 89 be, and the same is hereby, severed from the consolidated proceedings herein; and


IT IS FURTHER ORDERED that the claims in Dockets 13-F, 15-I, 27, 29-G, 64-A, 133-C, 141 and 308, proceed for the purpose of determining the acreage and fair market value, as of January 4, 1819, the effective date of the Treaty of September 29, 1817, of the lands ceded at said treaty, the consideration given for the cessions, and all other matters bearing upon the question of defendant's liability to the separate plaintiffs.
